2 **Resolution determining that the issuance of a Type 48 on-sale general public**  
3 **premises liquor license in exchange for a Type 47 on-sale general eating place**  
4 **liquor license at 1438 Grant Avenue to Claire Kozel for dba "SAVOY TIVOLI" will**  
5 **serve the public convenience and necessity of the people of the City and County**  
6 **of San Francisco, in accordance with Section 23958.4 of the California Business**  
7 **and Professions Code, with conditions.**

9 WHEREAS, Claire Kozel is seeking the issuance of a Type 48 on-sale general  
10 public premises liquor license in exchange for a Type 47 on-sale general eating place  
11 liquor license for dba "SAVOY TIVOLI" located at 1438 Grant Avenue; and,

12 WHEREAS, The City Planning Department has verified that the area is properly  
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license  
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business  
17 and Professions Code, the Board of Supervisors of the City and County of San  
18 Francisco hereby determines for the foregoing reasons that the issuance of a Type 48  
19 on-sale general public premises liquor license in exchange for a Type 47 on-sale  
20 general eating place liquor license at 1438 Grant Avenue to Claire Kozel for dba  
21 "SAVOY TIVOLI," will serve the public convenience and necessity of the people of the  
22 City and County of San Francisco.

23 Conditions: 1) A permanent awning made of sound absorbing material shall be  
24 installed on the exterior front of the building. The awning, at a minimum, shall run the  
25 entire length of the four (4) openings located in the patio area at the north end of the

1 building. The sound absorbing material used shall be a material approved for such use  
2 by a specialist in the field of acoustics; 2) Permanent shades consisting of sound  
3 absorbing material shall be installed in the interior of the building located above the two  
4 (2) fixed frame single pane windows (triangular in shape) at the southern end of the  
5 building. The sound absorbing material used shall be a material approved for such use  
6 by a specialist in the field of acoustics; 3) Permanent sound deadening tile board shall  
7 be installed on the ceiling in the patio area. The sound absorbing material used shall be  
8 a material approved for such use by a specialist in the field of acoustics; 4) The use of  
9 any amplifying system or device is prohibited in the patio area and the use of any such  
10 system or device inside the premises shall not be audible outside the premises; 5)  
11 Petitioner(s) shall regularly police the area under their control in an effort to prevent the  
12 loitering of persons about the premises; 6) Between the hours of 11:00 p.m. and 2:30  
13 a.m. the petitioner(s) shall provide personnel outside the premises to maintain order  
14 therein and prevent any activity, which would interfere with the quiet enjoyment of  
15 nearby residents. Said personnel shall be clothed in such a manner as to be readily  
16 identifiable with the premises.


