2 Center and improve the hospital trauma registry.]

3 **Resolution authorizing the San Francisco Department of Public Health, San Francisco**  
4 **County EMS Agency (SFDPH) to accept retroactively and expend a one year grant in**  
5 **the amount of \$912,440 from the California Emergency Medical Services Authority**  
6 **(CEMSA) to support the Trauma Center at San Francisco General Hospital and to enter**  
7 **into an agreement for the use of these funds; for the period of July 1, 2001 to June 30,**  
8 **2002.**

10 WHEREAS, SFDPH has applied for and been awarded a one year grant in the amount  
11 of \$912,440 from CEMSA to support the availability of services through the Trauma Center at  
12 San Francisco General Hospital; and,

13 WHEREAS, As a condition of receiving the grant funds, CEMSA requires the City to  
14 enter into an agreement (The "Agreement") a copy of which is on file with the Clerk of the  
15 Board of Supervisors in File No. 020181, which is hereby declared to be a part of  
16 this resolution as if set forth fully herein; and,

17 WHEREAS, SFDPH proposes to maximize use of available grant funds on program  
18 expenditures by not including indirect costs in the grant budget; now, therefore, be it

19 RESOLVED, That SFDPH, San Francisco County EMS Agency, is hereby authorized  
20 to accept retroactively and expend a grant in the amount of \$912,440 from CEMSA; and, be it


21 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
22 indirect costs in the grant budget; and, be it

23 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the  
24 grant funds in accordance with the requirements set forth in the Agreement pursuant to the  
25 San Francisco Administrative Code section 10-170-1; and, be it






