3 **Resolution authorizing the Municipal Railway Improvement Fund to accept and expend**
4 **a grant from the State of California's Employment Development Department to**
5 **establish a San Francisco MUNI Railway "Career Ladder" Program.**

7 WHEREAS, the Municipal Railway Improvement Fund is a Category Six Fund
8 established pursuant to Section 10-157 of the Administrative Code of the City and County of
9 San Francisco to establish and administer programs designed to advance the ability of MUNI
10 employees to service MUNI riders; and

11 WHEREAS, the Municipal Railway Improvement Fund has developed a "Career
12 Ladder" Program intended to provide MUNI employees with the training necessary to advance
13 within MUNI; and

14 WHEREAS, it is in the interest of the City and County of San Francisco to retain
15 qualified MUNI employees with the system; and

16 WHEREAS, the Municipal Railway Improvement Fund has applied for and been
17 awarded a grant from the State of California in the amount of \$500,000 for the Career Ladder
18 Program; and

19 WHEREAS, the San Francisco Administrative Code requires Board of Supervisors'
20 approval to accept and expend grants; now, therefore, be it

21 RESOLVED, that the Board of Supervisors of the City and County of San Francisco
22 hereby authorizes the City Controller to accept, on behalf of the Municipal Railway
23 Improvement Fund, a State grant of \$500,000 and authorizes the Municipal Railway
24 Improvement Fund to administer and expend funds for the Career Ladder Program grant; and

1 FURTHER RESOLVED, that indirect cost reimbursement is waived, subject to the
2 Controller being fully reimbursed for his services as a fiscal agent for said grant.




