13 WHEREAS, this San Francisco based group has financed many operations for the
14 sake of animals that have been endangered by various forces, such as the massive
15 exploitation of both land and animals themselves; and

16 WHEREAS, while protecting tigers in Cambodia, WildAid has striven to protect and
17 find new refuges for these animals; and

18 WHEREAS, by training and equipping wildlife law enforcement teams, and
19 campaigning internationally for truly effective wildlife protection, WildAid has helped sustain
20 and expand wildlife habitat so endangered species can flourish once again; and

21 WHEREAS, through its support of community based activities, engaging local
22 communities in wildlife monitoring and protection projects, and working with officials to find
23 economic alternatives to poaching and logging, WildAid has played a major role in the
