11 independence; and

13 WHEREAS, Rebuilding Together seeks community support to organize, train and
14 direct volunteers to raise the funds necessary to repair these homes and community facilities
15 of neighbor needs; and,

17 WHEREAS, This neighbor-helping-neighbor effort, culminating in a “National
18 Rebuilding Day” each April; and,

20 WHEREAS, This effort requires partnership between city government, private
21 businesses, skilled trades, community volunteers and contributors; and,

23 WHEREAS; Thousands of volunteers turned out for this past weekend’s “National
24 Rebuilding Day” to rebuild 33 homes of low-income, elderly homes and 15 nonprofit and
25 neighborhood facilities; now, therefore, be it


