

1 [Certification of Lower Cost of Services – Parking Meter Management System.]

3 **Resolution concurring with the Controller’s Certification that a proposed agreement**
4 **with Serco Management Services, Inc. for a parking meter management system which**
5 **includes collection and coin counting services, can be practically performed by a**
6 **private contractor for a lower cost than similar services performed by employees of the**
7 **City and County of San Francisco.**

9 WHEREAS, the electorate of the City and County of San Francisco passed Proposition
10 “J” in November 1976, adding Section 10.104.15 to the City Charter, allowing City
11 Departments to contract with private companies for specific services which can be practically
12 performed for a lower cost than similar work by City and County employees; and,

13 WHEREAS, The Purchasing Department issued a Request for Proposal for a Parking
14 Meter Management System on May 19, 1999; and,

15 WHEREAS, The response received from Serco Management Services for Collection
16 and Coin Counting Services has been determined to be cost effective; and,

17 WHEREAS, The Department of Parking and Traffic has determined that the services
18 provided by Serco Management Services, Inc. will not result in layoffs of any City employees;
19 and,

20 WHEREAS, The Controller certified on January 9, 2002 that the services evaluated
21 can be performed at a lower cost than by City employees at current salary and benefit levels,
22 a copy of which is on file with the Clerk of the Board of Supervisors in File No. 020495; and,

23 WHEREAS, The Parking and Traffic Commission adopted Resolution No. 181-01-PTC
24 on December 18, 2001, copy of which is on file with the Clerk of the Board of Supervisors in
25 File No. 020495 ; now, therefore, be it

1 RESOLVED, That the Board of Supervisors hereby concurs with the Controller's
2 certification and authorizes the Department of Parking and Traffic to contract for a Parking
3 Meter Management System.


