3 **Resolution authorizing the District Attorney to amend the current agreement in the**  
4 **amount of \$75,000 which has been allocated from the Victim Compensation and**  
5 **Governing Claims Board (formerly known as the State Board of Control), an agent of**  
6 **the State of California, for a revolving loan fund to be used to pay for verified**  
7 **funeral/burial expenses and emergency relocation for victims of domestic violence and**  
8 **sexual assault.**

10 WHEREAS, The City and County of San Francisco desires to continue the established  
11 contract with the Victim Compensation and Governing Claims Board (formerly known as the  
12 State Board of Control) to provide a means to pay for verified funeral/burial expenses and  
13 emergency relocation for victims of domestic violence and sexual assault; and,

14 WHEREAS, This contract would authorize the District Attorney's Victim Witness  
15 Assistance Program to pay verified funeral/burial expenses and emergency relocation for  
16 victims of domestic violence and sexual assault, and

17 WHEREAS, The fund established a process by which the County may pay providers  
18 from the fund and expedite payment and increase service to victims; now, therefore, be it

19 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of  
20 the City and County of San Francisco to amend the contract with the Victim Compensation  
21 and Governing Claims Board (formerly known as the State Board of Control); and be it

22 FURTHER RESOLVED, That the Auditor/Controller is directed to establish the  
23 requisite appropriations and revenue accounts for the receipt and distribution of funds  
24 allocated to the District Attorney; and be it






