3 **Resolution authorizing the Mayor’s Criminal Justice Council (MCJC) to accept and**  
4 **expend funds in the amount of \$2,651,098 from the State Board of Corrections, from**  
5 **funds made available through Senate Bill 736 – known as the Juvenile Justice Crime**  
6 **Prevention Act (JJCPA), for programs and approaches that have been demonstrated to**  
7 **be effective in reducing delinquency.**

9 WHEREAS, JJCPA provides for the continuation of funding originally created through  
10 the Schiff-Cardenas Crime Prevention Act of 2000, known as AB 1913; and

11 WHEREAS, MCJC is the lead programmatic and fiscal agency for the county in  
12 administering JJCPA, which provides funds for the county to continue implementing a  
13 comprehensive multi-agency juvenile justice plan; and

14 WHEREAS, JJCPA requires that the county’s local juvenile justice coordinating council,  
15 whose membership is described in Section 749.22 of the Welfare and Institutions Code,  
16 update its Juvenile Justice Local Action Plan and develop an expenditure plan for JJCPA;  
17 and,

18 WHEREAS, JJCPA also requires that the county Board of Supervisors, and in the case  
19 of a city and county the Mayor, approve the updated juvenile justice local action plan and the  
20 JJCPA expenditure plan; and

21 WHEREAS, The City established the Juvenile Justice Coordinating Council through  
22 resolution 170-97; and

23 WHEREAS, On March 20, 2002 the Juvenile Justice Coordinating Council met and  
24 recommended to the Board of Supervisors the expenditure plan for JJCPA; and

1           WHEREAS, The positions authorized under the grant are designated as "G" or "Grant  
2 Funded" positions which would terminate when the grant expires; and

3           WHEREAS, All funds provided through JJCPA are for direct services to youth, it is  
4 requested that indirect costs be waived; and

5           WHEREAS, MCJC has prepared all documentation required by the Board of  
6 Corrections, on file with the Clerk of the Board of Supervisors in File No. <sup>020639</sup> / , which is hereby  
7 declared to be a part of this resolution as if set forth fully herein; now, therefore, be it

8           RESOLVED, That the City and County of San Francisco hereby authorizes MCJC to  
9 accept and expend \$2,651,098 from the State Board of Corrections, under the JJCPA for  
10 programs and approaches that have been demonstrated to be effective in reducing  
11 delinquency; and, be it


12          FURTHER RESOLVED, That the County assures that the Board of Supervisors has  
13 reviewed and approves San Francisco's Application for Approval for the County's  
14 Comprehensive Multi-agency Juvenile Justice Plan Modification; and, be it

15          FURTHER RESOLVED, That the Director of the Mayor's Criminal Justice Council is  
16 authorized to sign San Francisco's Application for Approval for the County's Comprehensive  
17 Multi-agency Juvenile Justice Plan Modification and related contracts, amendments, or  
18 extensions with the State of California; and be it


19          FURTHER RESOLVED, That the City and County of San Francisco assures that it has

21 development, review and submission of the modification; and be it

22          FURTHER RESOLVED, That the City and County of San Francisco assures that it will  
23 adhere to the requirements of the JJCPA regarding the submission of the Comprehensive  
24 Multi-agency Juvenile Justice Plan Modification application, investment of allocated monies,


1 including any interest earnings, expenditure of said funds, and the submission of required


