

1 [Certification to Accompany Application for State Grant for Excelsior Library Renovation.]

3 **Resolution certifying project budget, local funding, supplemental funding and public**
4 **library operations pursuant to the California Reading and Literacy Improvement and**
5 **Public Library Construction and Renovation Bond Act of 2000.**

7 WHEREAS, The voters of the City and County of San Francisco passed Proposition A,
8 "Branch Library Facilities Improvement Bonds, 2000" that authorized the City to issue general
9 obligation bonds to acquire, remodel, or construct branch libraries and additional library
10 facilities; and

11 WHEREAS, The voters of the State of California passed Proposition 14, "The
12 California Reading and Literacy Improvement and Public Library Construction and Renovation
13 Bond Act of 2000" ("Bond Act") that provides state matching grants, on a competitive basis,
14 for qualifying library construction and remodeling projects; and

15 WHEREAS, The City and County of San Francisco seeks a state matching grant under
16 the Bond Act to remodel the San Francisco Public Library's Excelsior Branch Library; and,

17 WHEREAS, A copy of the City's proposed Bond Act grant application, including
18 application form and supporting documentation is on file with the Clerk of the Board of
19 Supervisors, which is hereby declared to be a part of this resolution as if set forth fully herein;
20 and,

21 WHEREAS, The Board of Supervisors is required under section 20440, Title 5 of the
22 California Code of Regulations to certify the Bond Act grant application; now, therefore, be it

23 **RESOLVED**, That Board of Supervisors hereby certifies the City's Bond Act grant
24 application, and commits as follows

25 (1) to provide the local matching funds in the amount of \$1,445,150;

1 (2) to provide supplemental funds necessary to complete the project in the
2 amount of \$190,000;

3 (3) to make the local matching and supplemental funds available when they are
4 needed to meet cash flow requirements for the project;


5 (4) to certify the good faith development of the project budget as contained in
6 the Library project budget section of the application form;

7 (5) to certify the accuracy and truthfulness of all information submitted in the
8 Application Form and the required supporting documents;


9 (6) to operate the completed remodeled Excelsior Branch Library and provide
10 public library direct service; and

11 (7) to dedicate the Excelsior Branch Library to public library direct service use
12 for a period of forty years following completion of the project, regardless of any
13 operating agreements the applicant may have with other jurisdictions or parties.


