3 **Resolution authorizing the District Attorney to retroactively accept and expend a grant**  
4 **in the maximum amount of \$75,000 per year from the California Office of Criminal**  
5 **Justice Planning for investigation and prosecution of high technology crimes.**

7 WHEREAS, The District Attorney has joined the Rapid Enforcement Allied Computer  
8 Team Taskforce (REACT Taskforce), which is funded by a grant from the California Office of  
9 Criminal Justice Planning; and,

10 WHEREAS, The REACT Taskforce consists of multiple agencies of local, State and  
11 Federal government which are coordinating in an effort to curb high technology crimes; and,

12 WHEREAS, The REACT Taskforce has made up to \$75,000 in grant funding available  
13 to the District Attorney so that the District Attorney may participate as a member of the  
14 REACT Taskforce; and,

15 WHEREAS, The District Attorney requests that indirect costs be waived in order to  
16 maximize use of funding on grant-related activities; now, therefore, be it

17 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
18 the grant budget; and be it

19 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the District  
20 Attorney to retroactively accept and expend up to \$75,000 per year for the duration of the  
21 Department's participation in the REACT Taskforce for the investigation and prosecution of  
22 high technology crimes; and be it

23 FURTHER RESOLVED, That the grant funds received hereunder shall not be used to  
24 supplant expenditures controlled by this body; and be it




