9 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) has taken a
10 leadership role in the resolution of issues surrounding Lake Merced and the Westside Basin
11 groundwater aquifer; and

12 WHEREAS, The SFPUC and the City of Daly City have reached agreement on
13 conducting a study to determine the feasibility of using available storage space in the
14 Westside Basin aquifer for the benefit of the SFPUC water system, with corresponding
15 benefits to management of Lake Merced water levels; and

16 WHEREAS, the SFPUC approved the proposed First Amendment to Water Supply
17 Contract with Daly City in Resolution No. 02-0042 dated February 26, 2002; and

18 WHEREAS, The First Amendment to the Water Supply Contract Between the City and
19 County of San Francisco and the City of Daly City for Purposes of Conducting an Aquifer
20 Recharge Study is on file with the Clerk of the Board of Supervisors in
21 File No. 020555, which is hereby declared to be a part of this resolution as if set
22 forth fully herein; and

23 WHEREAS, The contract amendment for conducting the aquifer recharge study is
24 categorically exempt under CEQA, State Guidelines, Section 15306, Class 6, Information
25 Collection; now therefore be it
