8 WHEREAS, The people of the State of California have enacted the California Oil  
9 Recycling Enhancement Act that provides funds to cities and counties for establishing and  
10 maintaining local used oil collection programs that encourage recycling or appropriate  
11 disposal of used oil; and,

12 WHEREAS, the California Integrated Waste Management Board has been delegated  
13 the responsibility for the administration of the program within the state, setting up necessary  
14 procedures governing application by cities and counties under the program; and,

15 WHEREAS, the City and County of San Francisco will enter into agreement with the  
16 State of California for implementation of used oil collection programs; and,

17 WHEREAS, the grant is a non-competitive grant that is available to the City and County  
18 of San Francisco from the California Integrated Waste Management Board; and,

19 WHEREAS, the grant terms prohibit including indirect costs in the grant budget; now,  
20 therefore, be it


21 RESOLVED, That the Director of the Department of the Environment, or a designee, is  
22 hereby authorized and empowered to execute in the name of the City and County of San  
23 Francisco all necessary applications, contracts, payment requests, agreements and  
24 amendments hereto for the purposes of securing grant funds and to implement and carry out  
25 the purposes specified in the grant application; and be it
