4 **of the Women's Health Center and commending UCSF for its continuing leading role in**

7 WHEREAS, The University of California, San Francisco ("UCSF") has been dedicated  
8 to provide high quality health care for women, demonstrated by their Center of Excellence in  
9 Women's Health; and,

10 WHEREAS, UCSF's Center of Excellence in Women's Health is one of fifteen national  
11 centers that stresses the importance and interdependence of clinical care, research,  
12 education, leadership development and community development in improving women's  
13 health; and,

14 WHEREAS, The Center of Excellence in Women's Health was honored by the U.S.  
15 Department of Health and Human Services by designation as a National Center of Excellence  
16 in Women's Health, one of six national recipients of such an honor; and,

17 WHEREAS, The newest addition to the Center of Excellence in Women's Health is the  
18 Women's Health Center, providing numerous services in an eight-story building, boasting  
19 centralized care, increasing efficiency and multidisciplinary care; and,

20 WHEREAS, The Women's Health Center will help women make informed decisions by  
21 supplying classes, education materials and information about clinical trials; and,

22 WHEREAS, Care will be further enhanced by cooperation with subspecialty clinics  
23 supplementing the existing specialty services network at Mt. Zion; now, therefore, be it




