3 **Resolution designating the San Francisco Independent to be the official newspaper of**
4 **the City and County of San Francisco for the category of non-consecutive day official**
5 **advertising, for the fiscal year commencing July 1, 2002 and ending December 31,**

8 WHEREAS, in each year, the Board of Supervisors shall designate the official
9 newspaper of the City and County of San Francisco, pursuant to Article IX, Section 2.80-1 and
10 2.81 of the San Francisco Administrative Code; now therefore, be it

11 RESOLVED, that the San Francisco Independent, a newspaper of general circulation
12 published in the City and County of San Francisco for the dissemination of local or telegraphic
13 news and intelligence of a general character, having a bona fide circulation of at least 50,000
14 copies per calendar week, printed in the City and County on three or more days in a calendar
15 week, is hereby designated as an official newspaper of the City and County of San Francisco,
16 commencing July 1, 2002, through December 31, 2002, for the publication of all official
17 advertising of the City and County which is required by law, other than the provisions of
18 Section 2.103 of the Charter as they relate to special meetings of the Board of Supervisors
19 and its special or standing committees, to be published one time, and all official advertising of
20 the City and County which is required by law to be published more than one, but not more
21 than three times per week for a specified number of weeks; and, be it

22 FURTHER RESOLVED, that the Office of Contract Administration is hereby authorized
23 to execute a contract with the San Francisco Independent and said contract must be in
24 accordance with all the contracting requirements of the City and County of San Francisco;
25 and, be it

1 FURTHER RESOLVED, that the Controller is to review the Independent circulation
2 audit before December 31, 2002.
