3 **Resolution urging the Presidio Trust to delay action on the Presidio Trust Management**  
4 **Plan to August 21, 2002.**

6 WHEREAS, The Presidio Trust was established to preserve and enhance the Presidio  
7 as a national park; and

8 WHEREAS, The Trust is responsible for overseeing the implementation of the Presidio  
9 Trust Management Plan (PTMP or Plan), which was established in 1994 to preserve the  
10 Presidio's natural, cultural, scenic and recreational resources; and,

11 WHEREAS, under this Plan, the Presidio will remain an open space preserved and  
12 enhanced for public use and enjoyment ;

13 WHEREAS, The Plan was modified in October 2001 to reflect input taken from the  
14 public;

15 WHEREAS, Increased input and response from the public about the Plan would be  
16 beneficial in creating an effective land use policy for the Presidio ;

17 WHEREAS, Open dialogue between the Presidio Trust and the public will lead to a  
18 more improved policy in addressing the preservation and future of the Presidio ;

19 WHEREAS, The public has expressed continued interest in preserving and promoting  
20 the scenic beauty of the Presidio through its support and suggested recommendations to the  
21 Plan; now, therefore, be it

22 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
23 does hereby urge the Presidio Trust to expand and sustain its partnership with all  
24 stakeholders, including the surrounding neighborhoods in the planning and creation of the

1 Presidio, as a recreational and historic area reflective of the beliefs and needs of all San  
2 Franciscans; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors does hereby urge the Presidio  
4 Trust to delay action on the Presidio Trust Management Plan to August 21, 2002 to allow for a  
5 more appropriate time period for consideration by all stakeholders regarding the Plan and its  
6 effects on the quality of life of San Francisco.
