10 WHEREAS, The people of the State of California have enacted Assembly Bill 1220
11 (Eastin, 1993) that provides grants to local governments to establish and implement waste
12 diversion and separation programs to prevent disposal of hazardous waste, including
13 household hazardous waste, in solid waste landfills; and,

14 WHEREAS, The California Integrated Waste Management Board has been delegated
15 the responsibility for the administration of the program within the state, setting up necessary
16 procedures governing application by cities and counties under the program; and,

17 WHEREAS, The applicant will enter into an agreement with the State of California for
18 the development of the project; and,


19 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
20 therefore, be it


21 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
22 the grant budget; and be it

23 FURTHER RESOLVED, That the City and County of San Francisco authorized the
24 submittal of an application to the California Integrated Waste Management Board for a Local
25 Government Household Hazardous Waste Grant, Fiscal Year 2002/2003; and be it

1 FURTHER RESOLVED, That the Director of the Department of the Environment, or
2 their designee is hereby authorized and empowered to execute in the name of the City and
3 County of San Francisco all necessary applications, contract payment requests, agreements
4 and amendments hereto for the purposes of securing grant funds and to implement and carry
5 out the purposes specified in the grant application.




