

1 [Extension of SRO Hotel Safety and Stabilization Task Force.]

2 **Resolution extending the operations of the Single Room Occupancy (SRO) Hotel Safety**
3 **and Stabilization Task Force through August 31, 2003.**

4 WHEREAS, In September 1999, in order to prevent further loss of low income housing
5 and to enhance the City and County of San Francisco's Emergency Response system, the
6 San Francisco Board of Supervisors created an advisory task force known as the Single
7 Room Occupancy (SRO) Hotel Safety and Stabilization task Force (the "SRO Task Force")
8 under Resolution No. 868-99, a copy of which is on file with the Clerk of the Board of
9 Supervisors in File No. 991429 and is hereby declared to be a part of this resolution as if set
10 forth fully herein; and

11 WHEREAS, The SRO Task Force makes recommendations to the Mayor and Board of
12 Supervisors regarding issues including, but not limited to, emergency response and follow-
13 through, fire mitigation efforts, structural rehabilitation of fire-damaged buildings, long-term
14 tenant stabilization and investigation, and prosecution of tenant rights, building code and fire
15 safety violations; and,

16 WHEREAS, The formal establishment of the SRO Task Force has been beneficial to
17 the City and County of San Francisco; and,

18 WHEREAS, The SRO Task Force requires additional time to monitor and address
19 policy issues concerning SRO hotel safety and stabilization; now, therefore, be it

20 RESOLVED, That Board of Supervisors hereby extends the operations of the SRO
21 Task Force, as described in Resolution 868-99, through August 31, 2003; and, be it

22 FURTHER RESOLVED, That if the SRO Task Force determines prior to August 31,
23 2003 that it will require additional time to complete its duties, it shall submit a written request
24 to the Board of Supervisors for a resolution extending the Task Force's operations.




