3 **Resolution approving the application for funds under the Voting Modernization Bond**  
4 **Act of 2002 (Proposition 41).**

6 WHEREAS, the people of the State of California have approved funding for the Voting  
7 Modernization Fund; and

8 WHEREAS, the Voting Modernization Board has been delegated the responsibility for  
9 the administration of the Voting Modernization Fund, setting up necessary procedures; and,

10 WHEREAS, said procedures established by the Voting Modernization Board require  
11 the City and County to certify by resolution the approval of applications before submission of  
12 said applications to the Voting Modernization Board; and,

13 WHEREAS, the City and County will enter into an agreement with the Voting  
14 Modernization Board for the continued modernization of voting equipment in San Francisco,  
15 which may include updates to the Optech Eagle ballot processing units, memory pack units,  
16 memory pack readers; ballot tabulation units, and additional hardware and software required  
17 for efficient and accurate tabulation of election results, as well as a possible transition to a  
18 touch screen voting methodology, now, therefore, be it

19 RESOLVED, That the San Francisco Board of Supervisors

- 20 1. Approves the filing of an application for assistance for the above projects to be  
21 funded from the Voting Modernization Act of 2002; and,  
22 2. Certifies that the City and County understands the assurances and certification in  
23 the Application form; and,




