3 **Resolution appointing Rick Lewis, term ending December 7, 2002 to the Community**
4 **Land Trust Task Force.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated person to serve as member of the Community
8 Land Trust Task Force, pursuant to the provisions of Resolution No. 680-01, for the term
9 specified:

10 Rick Lewis, succeeding David Jay-Bonn, resigned, seat 9, must be a member of an
11 existing community land trust organization, for the remainder of a 1 year term expiring
12 December 7, 2002; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 14 1. The membership of the Community Land Trust Task Force has a goal to be
15 representative of the diversity of the City and County of San Francisco.
- 16 2. Applicant Rick Lewis, a new appointee, who is not a resident of San Francisco, is a
17 person with experience that uniquely qualifies him/her to serve on the Community
18 Land Trust Task Force.
- 19 3. The Community Land Trust Task Force has attempted to fill the position, for which
20 Rick Lewis was nominated, with an individual who is a City resident and who has
21 the specific experience, skills, and qualifications, but has been unable to do so at
22 this time. The Rules Committee has certified that Rick Lewis is qualified to serve on
23 the Community Land Trust Task Force.
- 24 4. After exercising due diligence, the Board of Supervisors concludes that there is no
25 other possible representative, who is a resident of San Francisco and who has the

1 specific experience, skills, or qualifications possessed by this applicant, and who is
2 willing to serve on the Community Land Trust Task Force at this time; and, be it

4 FURTHER RESOLVED, That the Board of Supervisors waives the residency
5 requirement for Rick Lewis, as allowed in cases where no qualified City resident, willing to
6 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
7 appointed to boards, commissions, and advisory bodies established by legislative act of the
8 Board of Supervisors to be resident(s) of the City and County of San Francisco.


