3 **Resolution authorizing the Airport Commission to accept and expend a funding**
4 **increase from \$1,202,500 TO \$1,695,500 from the Federal Aviation Administration**
5 **("FAA") for the SFPD-AIRPORT Bureau K-9 Explosive Detection Team.**

8 WHEREAS, the SFPD-Airport Bureau K-9 Explosives Detection Team responds to
9 bomb treats at other Bay Area airports and municipalities; and,

10 WHEREAS, the SFPD-Airport Bureau K-9 Explosives Detection Team incurs
11 expenses for handler salaries, handler overtime, handler uniforms(laundry), K-9 food, K-9
12 veterinary care (medications), K-9 kenneling, vehicles, vehicle care and maintenance, handler
13 training/travel and explosives training/travel; and,

14 WHEREAS, Airport staff signed a modified Cooperative Agreement with the Federal
15 Aviation Administration ("FAA") office of Civil Aviation Security Operations, providing for
16 reimbursement of the SFPD Airport Bureau K-9 Explosives Detection Team expenses; and,

17 WHEREAS, The Airport received notification from the "FAA" of two funding increases
18 (\$252,500) for FY 1999/00 and (\$240,500) for FY 2000/01 totaling \$493,000, which brings the
19 total reimbursement to a minimum of \$1,695,000; and,


20 WHEREAS, the grant terms prohibit including indirect costs in the grant budget; and,

21 WHEREAS, On, January 22, 2002, pursuant to Resolution No. 02-0024, and on June
22 1, 1999, pursuant to Resolution No. 99-8122, the Airport Commission approved the SFPD-
23 AIRPORT Bureau K-9 Explosive Detection Team FAA grant reimbursements. A copy of which
24 is on file with the Clerk of the Board of Supervisors in File No. 021410 ;now, therefore, be it

RESOLVED, that this Board of Supervisors does hereby authorize the Airport to accept and expend the "FAA" funding increases for the SFPD-Airport Bureau K-9 Explosives Detection Team; and be it

FURTHER RESOLVED, that the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget.






