3 **Resolution extending the prescribed time within which the Planning Commission may**
4 **render its decision on a proposed ordinance to amend Article 10 of the Planning Code**
5 **by adding Appendix L designating the Dogpatch Historic District and make findings of**
6 **consistency with the priority policies of Planning Code Section 101.1 and the General**
7 **Plan.**

9 WHEREAS, On June 3, 2002, the Board of Supervisors initiated the process to amend
10 the San Francisco Planning Code, when the Honorable Sophie Maxwell introduced a
11 proposed ordinance to amend Article 10 of the Planning Code by adding Appendix L
12 designating the Dogpatch Historic District and make findings of consistency with the priority
13 policies of Planning Code Section 101.1 and the General Plan, a copy of which is on file with
14 the Clerk of the Board of Supervisors in File No. 020972, and,

15 WHEREAS, On June 10, 2002, the proposed ordinance was referred to the Planning
16 Commission, which currently is reviewing the proposed ordinance; and,

17 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by
18 resolution, extend the prescribed time within which the Planning Commission is to render its
19 decision on proposed amendments to the Planning Code initiated by the Board of
20 Supervisors; and,

21 WHEREAS, The Planning Department has requested additional time to review the
22 proposed ordinance; and,

23 WHEREAS, The Board deems it appropriate in this instance to grant to the Planning
24 Commission additional time to review the proposed ordinance and render its decision; now,
25 therefore, be it

1 RESOLVED, That by this resolution, the Board hereby extends the prescribed time
2 within which the Planning Commission may render its decision on the proposed ordinance to
3 amend Article 10 of the Planning Code by adding Appendix L designating the Dogpatch
4 Historic District and make findings of consistency with the priority policies of Planning Code
5 Section 101.1 and the General Plan, a copy of which is on file with the Clerk of the Board of
6 Supervisors in File No. 020972, for an additional ninety days, or until December 7, 2002.


