3 **Resolution urging the Municipal Transportation Agency Board of Directors to take all**
4 **necessary steps in mitigating unsafe traffic conditions in the Marina District,**
5 **specifically at the corner of Lombard and Fillmore Streets, including consideration of**
6 **the installation of a countdown light, and the installation of a lit crosswalk at this**
7 **intersection and working with the Office of the City Attorney and the San Francisco**
8 **Police Department in concert for a unified and collaborative effort to make safer streets**
9 **and ensure maximum pedestrian safety.**

11 WHEREAS, The City and County of San Francisco is committed to promoting the
12 health and safety of its citizens; and,

13 WHEREAS, Red light running has been recognized as an ongoing hazard to health
14 and safety; and,

15 WHEREAS, There are an estimated 3.5 million red light violations annually in San
16 Francisco of which the San Francisco Police Department issues more than 15,000 citations
17 annually; and,

18 WHEREAS, On August 25, 2002, a pedestrian was struck and killed by a red light
19 runner at the intersection of Lombard and Fillmore Streets in the Marina district; and,

20 WHEREAS, Traffic calming and red light running cameras have successfully
21 decreased the City-wide incidence of unlawful and reckless driving which too often results in
22 various types of accidents; now, therefore, be it

23 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
24 does hereby urge the Municipal Transportation Agency Board of Directors to take all
25 necessary steps in mitigating unsafe traffic conditions in the San Francisco Marina District,

1 specifically at the corner of Lombard and Fillmore Streets, including consideration of the
2 installation of a countdown light, and the installation of a lit crosswalk at this intersection and
3 working with the Office of the City Attorney and the San Francisco Police Department in
4 concert for a unified and collaborative effort to make safer streets and ensure maximum
5 pedestrian safety.




