8 WHEREAS, Section 2.103 of the City Charter requires the Board of Supervisors to  
9 meet in City Hall at 12:00 noon on the eighth day in January in each odd-numbered year, and  
10 further provides that thereafter the regular meetings of the Board shall be held on such dates  
11 and at such times as shall be fixed by resolution; and

12 WHEREAS, Section 2.116 of the City Charter requires the Board of Supervisors to  
13 elect one of its members as President for a two-year term on the eighth day of January in odd-  
14 numbered years; and

15 WHEREAS, The City Charter requires the Board to meet on Wednesday, January 8,  
16 2003, at 12:00 noon; and

17 WHEREAS, The Board of Supervisors wishes to establish Tuesdays at 2pm as the  
18 regular meeting days and times for the Board beginning after the January 8, 2003 meeting,  
19 and after the President of the Board who is elected on January 8, 2003, has had the  
20 opportunity to appoint standing committees; now, therefore, be it

21 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
22 hereby establishes Tuesdays at 2pm as the regular meeting days and times of the Board of  
23 Supervisors, beginning on ~~January 14~~ February 4, 2003; and, be it

24 FURTHER RESOLVED, That the Board of Supervisors rescinds Resolution No. 186-  
25 87, effective January 28, 2003, which established Mondays at 2pm as the days and times of




