6 WHEREAS, The Board of Supervisors approved the Agreement with PRWT Services,  
7 Inc. with Resolution No. 593-98 on July 31, 1998; and,

8 WHEREAS, The Department of Parking and Traffic has improved the quality of service  
9 provided to the public, become more efficient and has upgraded its information systems used  
10 for processing parking citations through its Agreement with PRWT, Services, Inc.; and,

11 WHEREAS, The Parking and Traffic Commission adopted Resolution 136-02-PTC on  
12 June 11, 2002 approving an extension to the Agreement with PRWT Services, Inc. and is on  
13 file with the Clerk of the Board of Supervisors in File No. 021284, which is hereby declared  
14 to be a part of this resolution as if set forth fully herein; and,

15 WHEREAS, The Department of Parking and Traffic is requesting the Board of  
16 Supervisors approve a ~~Second~~ Third Amendment to the Agreement with PRWT Services, Inc.  
17 which includes a two-year extension because the contract benefits have exceeded the costs;  
18 now, therefore, be it

19 RESOLVED, That Board of Supervisors of the City and County of San Francisco  
20 hereby approves the proposed ~~Second~~ Third Amendment to the Agreement with PRWT  
21 Services, Inc.; and, be it

22 FURTHER RESOLVED, That Board of Supervisors of the City and County of San  
23 Francisco authorizes the Executive Director of the Department of Parking and Traffic to enter  
24 into the ~~Second~~ Third Amendment to the Agreement in substantially the form of such Second
