4 **Resolution accepting and expending a gift valued at \$50,000.00 and a gift-in-place**  
5 **valued at approximately \$35,000.00 from the Friends of Recreation and Parks to the**  
6 **Recreation and Park Department for Moscone Park.**

8 WHEREAS, The City owns real property located in the Marina District known as  
9 “Moscone Park Playground”; and,

10 WHEREAS, Through a series of community meetings, a conceptual plan for making  
11 improvements at the Moscone Park Playground was developed and approved by the  
12 Recreation and Park Commission in 2000. Subsequently, the improvements were completed  
13 in April 2002 and,

14 WHEREAS, the Friends of Recreation and Park has donated a gift of \$50,000 through  
15 a donation received from the GAP, Inc.; and

16 WHEREAS, the Friends of Recreation and Park has offered to donate as a Gift-in-  
17 Place valued at approximately \$35,000 of two Bronze Sculptures, a starfish and a sea turtle  
18 which has received the approval of the community and the Arts Commission and,

19 WHEREAS, the Recreation and Park Commission has recommended to the Board of  
20 Supervisors to accept and expend the Gift and the Gift-in-place; now, therefore, be it

21 RESOLVED, That the Board of Supervisors authorizes the General Manager of the  
22 Recreation and Park Department to accept and expend the Gift of \$50,000 and the Gift-in-  
23 place valued at approximately \$35,000 from the Friends Recreation and Park received from  
24 the Friends of Moscone Park and Recreation Center.
