3 **Resolution accepting and expending a gift-in-place valued at maximum of \$750,000.00**  
4 **from the Friends of Recreation and Parks to the Recreation and Park Department to be**  
5 **used for the Children’s Play Area located at the Julius Kahn Playground.**

7 WHEREAS, The City maintains and operates real property located in the Presidio of  
8 San Francisco known as “Julius Kahn Playground”; and,

9 WHEREAS, The Children’s Play Area has not received any major renovation since  
10 1978; and

11 WHEREAS, Through a series of community meetings, a conceptual plan for  
12 improvements at Julius Kahn Playground will be developed and approved by the Recreation  
13 and Park Commission; and,

14 WHEREAS, The Friends of Recreation and Parks has offered to donate a gift-in-place  
15 for the design, construction and implementation of the Children’s Play Area in Julius Kahn  
16 Playground; and,

17 WHEREAS, At the September 2002 meeting of the Recreation and Park Commission,  
18 the gift-in-place in conjunction with a Memorandum of Understanding, entered between the  
19 Friends of Recreation and Parks, the City and County of San Francisco Recreation and Park  
20 Department and the Presidio Trust was heard; and,

21 WHEREAS, Through the Recreation and Park Commission resolution number 0209-  
22 013, the Commission recommended to the Board of Supervisors to accept and expend the  
23 gift-in-place; now, therefore, be it

24 RESOLVED, That the Board of Supervisors does hereby authorize the General Manager of  
25 the Recreation and Park Department to accept and expend the gift-in-place valued at a

1 maximum of \$750,000.00 from the Friends Recreation and Parks to be used for the  
2 Children's Play Area located at Julius Kahn Plaground.


