3 **Resolution fixing the highest general prevailing rate of wages for various crafts and**
4 **kinds of labor, and for janitorial services, as paid for similar work in private**
5 **employment in the City and County of San Francisco, at the rates certified to the Board**
6 **by the Civil Service Commission on September 16, 2002.**

8 WHEREAS, The Board of Supervisors, in accordance with Administrative Code section
9 6.22, is required to fix the highest general prevailing rate of wages, including wages paid for
10 holiday and overtime work, for various crafts and kinds of labor as paid for similar work in
11 private employment in the City and County of San Francisco; and

12 WHEREAS, The Board of Supervisors, in accordance with Administrative Code section
13 21.25-1, is required to fix the prevailing rate of wages, including wages paid for holiday and
14 overtime work, and fringe benefits or an equivalent amount, for janitorial services as paid for
15 similar work in private employment in the City and County of San Francisco; and,

16 WHEREAS, The Civil Service Commission at its meeting of September 16, 2002,
17 certified and forwarded to the Board of Supervisors data as to the highest general prevailing
18 rate of wages, including wages paid for holiday and overtime work, for various crafts and
19 kinds of labor as paid for similar work in private employment in the City and County of San
20 Francisco. A copy of the certified data is on file with the Clerk of the Board of Supervisors in
21 File No. 021579, which is hereby declared to be a part of this resolution as if set forth fully herein;
22 and,

23 WHEREAS, The Civil Service Commission at its meeting of September 16, 2002,
24 certified and forwarded to the Board of Supervisors data as to the prevailing rate of wages,
25 including wages paid for holiday and overtime work, and fringe benefits or an equivalent

1 amount, for janitorial services as paid for similar work in private employment in the City and
2 County of San Francisco. A copy of the certified data is on file with the Clerk of the Board of
3 Supervisors in File No. ⁰²¹⁵⁷⁹, which is hereby declared to be a part of this resolution as if set
4 forth fully herein; now, therefore, be it

5 RESOLVED, That the Board of Supervisors hereby adopts the data certified by the
6 Civil Service Commission at its meeting of September 16, 2002, and fixes the highest general
7 prevailing rate of wages, including wages paid for holiday and overtime work, for various
8 crafts and kinds of labor as paid for similar work in private employment in the City and County
9 of San Francisco at the rates specified therein; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors hereby adopts the data certified
11 by the Civil Service Commission at its meeting of September 16, 2002, and fixes the
12 prevailing rate of wages, including wages paid for holiday and overtime work, and fringe
13 benefits or an equivalent amount, for janitorial services as paid for similar work in private
14 employment in the City and County of San Francisco at the rates specified therein.


