8 Advisory Task Force, and provided an expiration date for the Task Force of December 31,
9 2000; and,

10 WHEREAS, Resolution No. 362-99 has been amended by Resolutions No. 564-99,
11 1055-00, and 139-01; and,

12 WHEREAS, Resolution No. 1055-00 extended the expiration date of the Task Force
13 from December 31, 2000, to October 31, 2001; and,

14 WHEREAS, Resolution No. 011966 extended the expiration date of the Task Force
15 from October 31, 2002, to November 1, 2002; and,

16 WHEREAS, The Board of Supervisors wishes to expand the composition of the Task
17 Force to include broader geographic representation; and,

18 WHEREAS, The current members of the Potrero Power Plant Advisory Task Force are
19 appointed by the President of the Board of Supervisors; and,

20 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
21 hereby extends the Potrero Power Plant Citizens Advisory Task Force's timeline from
22 November 1, 2002 to November 1, 2003; and,

23 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
24 Francisco hereby adds two (2) additional members to the Potrero Power Plant Citizens
