3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**
4 **accept and expend retroactively a grant in the amount of \$1,000,000 from the**
5 **Substance Abuse and Mental Health Services Administration (SAMHSA) to continue**
6 **treatment on demand services and evaluation and to enter into an agreement for the**
7 **use of these funds; for the period of August 1, 2002, to July 31, 2003.**

9 WHEREAS, SFDPH was awarded a grant from SAMHSA to continue and evaluate
10 treatment on demand substance abuse services in San Francisco; and,

11 WHEREAS, SAMHSA has agreed to reimburse SFDPH in the amount of \$1,000,000
12 under the terms of this award; and,

13 WHEREAS, As a condition of receiving the funds SAMHSA requires SFDPH to enter
14 into an agreement ("The Agreement"), "Terms and Conditions of Award", a copy of which is
15 on file with the Clerk of the Board of Supervisors in File No. 021585, which is hereby
16 declared to be a part of this resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes provision for indirect costs of \$36,345; now,
18 therefore, be it

19 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a
20 grant in the amount of \$1,000,000 from SAMHSA; and, be it


21 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
22 grant funds in accordance with the requirements set forth in the Agreement pursuant to San
23 Francisco Administrative Code section 10-170-1; and, be it

24 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
25 Agreement on behalf of the City; and, be it


1 FURTHER RESOLVED, That the Controller is directed to designate the positions
2 created under the grant as "G" or grant-funded positions, which would terminate when the
3 grant expires.


