3 **Resolution approving the expenditure of funds for emergency contract CW-336E in the**  
4 **amount of \$441,000 to replace variable frequency drives for main lift pumps at the**  
5 **Southeast Water Pollution Control Plant.**

7 WHEREAS, The existing variable frequency drives (VFDs) for the main lift pumps at  
8 the Southeast Water Pollution Control Plant (SEWPCP) are failing and causing damage to the  
9 main lift pump motors; and

10 WHEREAS, The main lift pumps are the primary means of moving sewage from the  
11 Bayview Hunters Point community into the SEWPCP for treatment; and,

12 WHEREAS, Failure of the lift pumps will result in violation of the SEWPCP's NPDES  
13 permit and will also be a threat to public health and safety; and,

14 WHEREAS, The General Manager of the San Francisco Public Utilities Commission  
15 (SFPUC) requested an emergency contract to replace existing variable frequency drives for  
16 the main lift pumps at the SEWPCP, by a letter dated April 25, 2002; and,

17 WHEREAS, The emergency contract was issued on May 7, 2002 to the contractor,  
18 Sierra Electric Company; and,

19 WHEREAS, The Declaration of Emergency was ratified for Clean Water Program  
20 Contract No. CW-336E, SEWPCP Bldg. 011 Main Lift Pumps VFDs Replacement, by SFPUC  
21 Resolution No. 02-0151, dated August 13, 2002; and,

22 WHEREAS, The emergency contract award amount is \$441,000, and the contract  
23 duration is 180 consecutive calendar days; and,

8 12D.A of the San Francisco Administrative Code for an emergency contract; now, therefore,

11 in the amount of \$441,000 for Clean Water Program Emergency Contract No. CW-336E,  
12 SEWPCP Bldg. 011 Main Lift Pumps VFDs Replacement.
