3 **Resolution requesting support of the Board of Supervisors for the Future Work**  
4 **Plan of the San Francisco Local Agency Formation Commission.**

6 WHEREAS, The primary purpose of the San Francisco Local Agency Formation  
7 Commission (San Francisco LAFCo or Commission) under the Cortese-Knox-Hertzberg  
8 Local Government Reorganization Act of 2000 is to review public service needs,  
9 including utility service, and to determine whether new government entities should be  
10 created or changes in existing governments should be made to address the needs of its  
11 citizens;

12 WHEREAS, The Commission adopted by resolution its Energy Services Study  
13 and Recommendations for Electric Utility Service;

14 WHEREAS, The Study indicates that reliable, reasonably priced electric service  
15 is vital to the City's economic health and public welfare;

16 WHEREAS, The San Francisco Local Agency Formation Commission has  
17 adopted on November 8, 2002 by Resolution No. 02-03, a Future Work Plan that  
18 includes pursuing a strategic plan for power supply, transmission, and distribution to the  
19 City and County of San Francisco and other work plan items as follows:

20 1. Development and adoption of a conceptual model of governance for the  
21 energy future of the City and County of San Francisco by:

22 a. The SFPUC as an aggregator of retail electricity loads and an Energy  
23 Service Provider (ESP) based on the SFPUC/SFDOE Electricity  
24 Resources Plan published in March 2002, the proposed charter  
25 amendments to restructure the SFPUC, submitted on June 17, 2002,

1 newly enacted sections 331.1, 366.2 and 381.1 of the Public Utilities Code  
2 to permit community aggregation, and the conceptual model for SFPUC  
3 contained in the Energy Services Study; or

4 b. A separate municipal electric utility created by the Board of Supervisors  
5 with an elected governing body or a governing body appointed by the  
6 Mayor or Board of Supervisors;

7 2. Development of an integrated Long-Term Resources Plan, including financial  
8 and competition plans for support;

9 3. Confirmation or modification of the preferred energy supplier role for SFPUC,  
10 including a risk assessment and an evaluation of benefits provided to  
11 customers, as compared to costs and services that are likely to be available  
12 from competing service providers;

13 4. Assuming confirmation of an energy supply role for SFPUC, monitor and  
14 support legislative and regulatory activities that provide for Direct Access and  
15 Community Aggregation (e.g. AB 117);

16 5. Development of a Risk Management Plan for the selected energy service  
17 model and development of an Implementation Plan;

18 6. Consideration of SFPUC's acquisition of PG&E's distribution system in  
19 accordance with the Energy Services Study;

20 7. Development of a Financing Plan to fund the costs of the Energy Services  
21 Study recommendations;

22 WHEREAS, Further, the San Francisco Local Agency Commission has approved  
23 as a part of its Future Work Plan the following:  
24  
25

- 1           1. Pursuing possible energy power resource options through the water utility,  
2           including, but not limited to exploring desalinization, studying the tidal current  
3           generation; and implementing of a recycled water program;  
4           2. Review of those specific public services provided by the City and County of  
5           San Francisco through contracts and agreements with publicly funded non-  
6           profit corporations and other non-profit entities; and

7           WHEREAS, The San Francisco Local Agency Formation Commission  
8           determines that it is advisable for the Board of Supervisors to be notified of the  
9           proposed Future Work Plan and, further, the Commission requests that the Board of  
10          Supervisors express its support for the Future Work Plan; now, therefore, be it

11          RESOLVED, That the Board of Supervisors extends its support for the San Francisco  
12          Local Agency Formation Commission’s Future Work Plan.




