Resolution authorizing the San Francisco Department of Public Health (SFPDH) to accept and expend retroactively a grant in the amount of \$186,000 from the California Family Health Council, Inc. (CFHC), to enhance and expand HIV/AIDS confidential counseling and testing services in family planning agency clinics and to enter into an agreement for the use of these funds; for the period of September 1, 2002, through August 31, 2003.

WHEREAS, The SFPDH has applied for and been awarded a grant from the CFHC in the amount of \$186,000 to enhance and expand HIV/AIDS confidential counseling and testing services in family planning agency clinics; and,

WHEREAS, As a condition of receiving the grant funds, CFHC requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of Supervisors in File No. 021809, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

WHEREAS, The grant budget includes provision for indirect costs of \$19,982; now, therefore, be it

RESOLVED, That the SFPDH is hereby authorized to accept and expend retroactively a grant in the amount of \$186,000 from CFHC; and, be it

FURTHER RESOLVED, That the SFPDH is hereby authorized to accept and expend the grant funds in accordance with the requirements set forth in the Agreement pursuant to San Francisco Administrative Code section 10-170-1; and, be it
