17 natural areas, including environmental interest advocacy; academic ecology; open space  
18 restoration; and water and soil erosion. The term shall expire on December 1, 2003 when the  
19 Committee sunsets unless otherwise extended by the Board of Supervisors.

20 Edward Conner, new position, seat 3, must be knowledgeable in issues related to  
21 natural areas, including environmental interest advocacy; academic ecology; open space  
22 restoration; and water and soil erosion. The term shall expire on December 1, 2003 when the




