1 [Provide behavioral health services for formerly homeless persons at six locally funded  
2 supportive housing sites in San Francisco.]

4 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
5 **accept and expend retroactively \$599,769 for the first year of a three year grant from**  
6 **the Substance Abuse and Mental Health Services Administration (SAMHSA) to provide**  
7 **behavioral health services for formerly homeless persons living at supportive housing**  
8 **sites in San Francisco and to enter into an agreement for the use of these funds; for**  
9 **the period of September 30, 2002 to September 29, 2003.**

11 WHEREAS, SFDPH has applied for and been awarded a grant from SAMHSA in the  
12 amount of \$599,769 for the first year of three years to provide behavioral health services for  
13 formerly homeless persons; and,

14 WHEREAS, As a condition of receiving the grant funds, SAMHSA requires the City to  
15 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the  
16 Board of Supervisors in File No. 021841, which is hereby declared to be a part of  
17 this resolution as if set forth fully herein; and,

18 WHEREAS, The first year grant budget includes provision for indirect costs of \$14,629;  
19 now, therefore, be it

20 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a  
21 grant in the amount of \$599,769 from SAMHSA; and, be it

22 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the  
23 grant funds in accordance with the requirements set forth in the Agreement pursuant to San  
24 Francisco Administrative Code section 10-170-1; and, be it






