3 **Resolution authorizing the Sheriff's Department to accept and expend a grant in the**
4 **amount of \$498,455 from the U.S. Department of Health and Human Services,**
5 **Substance Abuse and Mental Health Administration for providing a substance abuse**
6 **program to recently released offenders.**

8 WHEREAS, The U.S. Department of Health and Human Services, Substance Abuse
9 and Mental Health Administration has made available funding through the Targeted Capacity
10 Expansion program; and,

11 WHEREAS, Due to the need for substance abuse services and counseling among
12 recently incarcerated people, the Sheriff's Department will offer a program to address
13 substance abuse and related issues among offenders recently released from custody; and,

14 WHEREAS, The grant budget includes provision for indirect costs of \$17,623; and,

15 WHEREAS, The grant identifies matching non-federal funds of \$107,290 now,
16 therefore, be it

17 RESOLVED, That a grant award notification has been received from the U.S.
18 Department of Health and Human Services, Substance Abuse and Mental Health
19 Administration; and, be it


20 FURTHER RESOLVED, That the grant provides for the creation of five positions as
21 follows: 1) Class 8420 – Rehabilitation Services Coordinator at a salary of \$ 59,645 plus
22 benefits; 2) Class 1424 -- Clerk Typist at a salary of \$37,041; 3) 8306 – Senior Deputy (.50
23 FTE) at a salary of \$34,339; 4) Class 2585 – Health Worker I (.50 FTE) at a salary of
24 \$20,449; 5) Class 2803 – Epidemiologist and (.33 FTE) at a salary of \$18,558, be it




1 FURTHER RESOLVED, That the City & County of San Francisco will adhere to the
