3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**
4 **accept and expend retroactively a grant in the amount of \$113,788 from the California**

9 WHEREAS, SFDPH has been awarded a grant from CDHS in the amount of \$113,788
10 to plan and implement services to support healthy eating and childhood overweight prevention
11 services in San Francisco; and,

12 WHEREAS, As a condition of receiving the grant funds, CDHS requires the City to
13 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the
14 Board of Supervisors in File No. 030032, which is hereby declared to be a part of
15 this resolution as if set forth fully herein; and,

16 WHEREAS, The grant budget includes provision for indirect costs of \$9,061; now,
17 therefore, be it

18 RESOLVED, That SFDPH is hereby authorized to accept and expend retroactively a
19 grant in the amount of \$113,788 from CDHS; and, be it

20 FURTHER RESOLVED, That SFDPH is hereby authorized to accept and expend the
21 grant funds in accordance with the requirements set forth in the Agreement pursuant to San
22 Francisco Administrative Code section 10-170-1; and, be it


23 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
