3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
4 **enter retroactively into an agreement in the amount of \$84,328.13 with The Regents of**  
5 **the University of California San Francisco (UCSF), the primary contractor, to extend**  
6 **current child care health consultation services to family childcare providers, for the**  
7 **period of July 1, 2002 to June 30, 2003.**

9 WHEREAS, UCSF is the recipient of a grant award from the State of California,  
10 California Children and Families Commission (CCFC) for the conduct of a program entitled  
11 "Child Care Health Linkages Project"; and,

12 WHEREAS, It is considered in the best interests of CCFC, UCSF, and SFDPH to  
13 participate in this project; and,

14 WHEREAS, UCSF has agreed to reimburse SFDPH in the amount of \$84,328.13  
15 under the terms of this agreement; and,

16 WHEREAS, As a condition of receiving the funds UCSF requires SFDPH to enter into a  
17 subcontract (The "Agreement"), a copy of which is on file with the Clerk of the Board of  
18 Supervisors in File No. 030023, which is hereby declared to be a part of this  
19 resolution as if set forth fully herein; and,


20 WHEREAS, The contract budget includes provision for indirect costs of \$4,015.625;  
21 now, therefore, be it

22 RESOLVED, That SFDPH is hereby authorized to enter retroactively into a subcontract  
23 agreement in the amount of \$84,328.13 with UCSF, the primary contractor, for services under  
24 the "Child Care Health Linkages Project"; and, be it

1 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
2 agreement on behalf of the City; and, be it

3 FURTHER RESOLVED, That the Controller is directed to designate all positions  
4 funded under this agreement as "G" or grant-funded positions which would terminate when  
5 the agreement expires.
