3 **Rescinding Resolution No. 193-98; Authorizing designated City and County officials to**  
4 **execute and file on behalf of the City and County of San Francisco applications for**  
5 **federal and state financial assistance under the Emergency Management Performance**  
6 **Grant Program, the State Domestic Preparedness Grant Program, and Public Law 107-**  
7 **26.**

8 WHEREAS, The State of California through its Emergency Management Performance  
9 Grant Program provides support for the development and maintenance of the capability of  
10 local jurisdictions to prepare for, mitigate, respond to, and recover from emergencies and  
11 disasters; and,

12 WHEREAS, The State of California through its Domestic Preparedness Grant Program  
13 provides support for the development and maintenance of the capability of local jurisdictions  
14 to prepare for and respond to terrorist attacks using weapons of mass destruction and  
15 provides for the dispersal of federal funds provided for this purpose under Public Law 107-  
16 206; and,

17 WHEREAS, The City and County of San Francisco has participated in these programs  
18 since their inception and deems participation in these programs as vital to the continued well  
19 being of its citizens; and,

20 WHEREAS, The State of California requires that applicant's agents be named by  
21 resolution: now therefore, be it

22 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
23 rescinds Resolution No. 193-98 and authorizes the Director of Emergency Services of the City  
24 and County of San Francisco, or in his or her absence the Controller of the City and County of  
25 San Francisco to execute for and on behalf of the City and County of San Francisco, a public  
entity established under the laws of the State of California, any applications, assurances, and  
documents necessary for the purpose of obtaining federal and state financial assistance

under the Emergency Management Performance Grant Program and the State Domestic Preparedness Grant Program and under Public Law 107-206.
