3 **Resolution authorizing the Department of the Environment to retroactively accept and**
4 **expend a grant in the amount of \$9,765.23 from the California Integrated Waste**

8 WHEREAS, The Department of the Environment seeks to divert 50% from the City's
9 waste stream in accordance with state mandated goals set forth in AB939, and,

10 WHEREAS, Resolution 02-1468 established a goal of 75% landfill diversion by 2010
11 and zero waste thereafter; and,

12 WHEREAS, Recycling, by definition, requires the remanufacture of recovered materials
13 into new products, and,

14 WHEREAS, There is a pressing need to identify manufacturers to use recovered
15 materials in the making of new products and markets for those products to be sold in, and,

16 WHEREAS, The California Integrated Waste Management Board designated the City
17 and County of San Francisco as a participating jurisdiction in the Recycling Market
18 Development Zone program in 1995; and,

19 WHEREAS, The California Integrated Waste Management Board has made available
20 to the Department of the Environment \$9,765.23 in funds from the Recycling Market
21 Development Zone program for the purpose of identifying and promoting manufacturers who
22 use recycled materials in their products; now, therefore be it

23 RESOLVED, That the Board of Supervisors hereby authorizes the Department of the
24 Environment to retroactively accept and expend \$9,765.23 from the California Integrated
25 Waste Management Board; and be it




