11 alcoholic beverage control license for True Sake, LLC located at 560 Hayes Street; and,

12 WHEREAS, The City Planning Department has verified that the area is properly  
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license  
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business  
17 and Professions Code, the Board of Supervisors of the City and County of San  
18 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
19 off-sale general alcoholic beverage control license from 1419 Stockton Street to 560  
20 Hayes Street for Beau Timken for True Sake, LLC, will serve the public convenience  
21 and necessity of the people of the City and County of San Francisco.

22 Conditions: (1) Sales and service of alcoholic beverages shall be permitted only  
23 between the hours of 10:00 a.m. to 8:00 p.m. each day of the week; (2) The petitioner(s)  
24 shall be responsible for maintaining free of litter the area in front of and adjacent to the  
25 premises over which they have control; (3) Inventory and sales of alcoholic beverages

1 shall be limited to Rice Wines (Sake), Rice Based Beverages, Plum Wines and  
2 Imported Japanese Beers.


