3 **Resolution Authorizing the Chief of Police for the City and County of San Francisco to**
4 **retroactively accept and expend grant funds made available through the U.S.**

5 **Department of Justice – Office of Community Oriented Policing for a project entitled**
6 **“COPS-MORE 2002; Crime Analysis Hardware and Software”.**

8 WHEREAS, the Chief of Police of the City and County of San Francisco is authorized
9 to undertake a certain project designated “COPS-MORE 2002; Crime Analysis Hardware and
10 Software”, to be funded in part from funds made available through the U.S. Department of
11 Justice – Office of Community Oriented Policing Services (DOJ/COPS); and,

12 WHEREAS, this grant funding will provide much needed computer equipment and
13 mapping software for the ever increasing area of crime analysis, and

14 WHEREAS, the grant terms prohibit inclusion of indirect costs in the grant budget; now,
15 therefore, be it

16 RESOLVED, That the Chief of Police of the City and County of San Francisco is
17 authorized to execute on behalf of the City and County of San Francisco the attached Grant
18 Award Agreement for this project, including any extensions, funding augmentations from DOJ,
19 or amendments thereof; and be it

20 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
21 indirect costs in the grant budget; and be it

22 FURTHER RESOLVED, That it is agreed that any liability arising out of the
23 performance of this Grant Award Agreement, including civil court actions for damages, shall
24 be the responsibility of the grantee and the authorizing agency. The United States
25 Government and DOJ disclaim responsibility for and such liability; and be it


