**Resolution extending the prescribed time within which the Planning Commission may render its decision on a proposed ordinance to amend the San Francisco Planning Code by amending Sections 311 and 312 to require expanded public notice of exterior alteration projects and requiring the Building and Planning Departments to issue implementing regulations within 90 days and report to the Board on the effectiveness of the ordinance no later than nine months thereafter.**

WHEREAS, On December 16, 2002, Supervisor Jake McGoldrick introduced legislation to amend the Planning Code by amending Sections 311 and 312 to require expanded public notice of exterior alteration projects and requiring the Building and Planning Departments to issue implementing regulations within 90 days and report to the Board on the effectiveness of the ordinance no later than nine months thereafter; and,ac

WHEREAS, It is unclear when the Planning Department actually received a copy of the legislation from the Clerk's Office, but the Department began reviewing the legislation sometime during the week of January 27, 2003; and,

WHEREAS, Planning Code Section 306.4(d)(3) provides that the Planning Commission must render its decision on proposed legislation within 90 days of the date of referral and that failure to action within the prescribed time shall constitute disapproval; and,

WHEREAS, Planning Code Section 306.4.(d)(3) authorizes the Board of Supervisors to extend by resolution the prescribed time within which the Commission is to render its decision on legislation initiated by the Board; and,


