

1 [Accept-Expend Foundation Grant]

2 **Resolution authorizing the Department of Environment to accept and expend a grant in**
3 **the amount of \$50,000 from the San Francisco Foundation for locating air monitoring**
4 **equipment in San Francisco's Bayview Hunters Point community, placing \$10,000 on**
5 **reserve.**

6 WHEREAS, Based upon evaluation of responses to a San Francisco Foundation
7 request for proposals, the Department of the Environment's Environmental Justice Program
8 was selected to be the recipient of \$50,000 in funding to locate a state-of-the-art air monitor in
9 Bayview Hunters Point; and,

10 WHEREAS, The Mayor's Health and Environmental Task Force has declared an
11 environmental health emergency in Bayview Hunters Point, and,

12 WHEREAS, Bayview Hunters Point has high rates of asthma and other respiratory
13 health problems which may be caused by air pollution; and,

14 WHEREAS, This grant will allow the Department of the Environment to assess specific
15 pollutants and sources of pollutants; and,

16 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
17 therefore, be it


18 **RESOLVED**, That the San Francisco Board of Supervisors authorizes the Director of
19 the Department of the Environment to accept and expend funding of \$50,000 from the San
20 Francisco Foundation to locate air monitoring equipment in Bayview Hunters Point, with
21 \$10,000 placed on reserve; and be it

22 **FURTHER RESOLVED**, That the Board of Supervisors hereby waives inclusion of
23 indirect costs in the grant budget.


