8 WHEREAS, The District Attorney and the City and County of San Francisco desires to  
9 enter into an agreement with the California Victim Compensation and Government Claims  
10 Board in accordance with Government Section 13835 for the purpose of verification of victim  
11 compensation claims; and,

12 WHEREAS, Grant funds received hereunder shall not be used to supplant local funds  
13 that would, in the absence of California Victim Compensation and Government Claims Board  
14 Programs, be made available to support the assistance of victims and witnesses of crime;  
15 and,

16 WHEREAS, All positions supported by these funds shall be coded "G" in the District  
17 Attorney's budget; and,

18 WHEREAS, The District Attorney requests that indirect costs be waived in order to  
19 maximize use of funding on grant-related activities; now, therefore, be it

20 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
21 the grant budget; and be it

22 FURTHER RESOLVED, That the District Attorney of the City and County of San  
23 Francisco is authorized on behalf of the City and County of San Francisco to contract for,  
24 accept and expend funds from the California Victim Compensation and Government Claims






