8 WHEREAS, The State of California, under Welfare and Institutions Code 12300,  
9 mandates that all counties provide the In-Home Supportive Services (IHSS) Program, which  
10 provides supportive services to eligible blind, aged, and disabled persons in order to enable  
11 these individuals to remain safely in their homes; and,

12 WHEREAS, The City and County of San Francisco, pursuant to California Welfare and  
13 Institutions Code 12301.6, has created through legislation the San Francisco In-Home  
14 Supportive Services Public Authority to provide for the delivery of In-Home Supportive  
15 Services and to be the employer of record for the Independent Providers; and,

16 WHEREAS, The City and County of San Francisco wishes to provide health and dental  
17 benefits to the Independent Providers of IHSS; therefore be it

18 /10/03 RESOLVED, That the Board of Supervisors hereby<sup>retroactively</sup> approves the contract with the San  
19 Francisco In-Home Supportive Services Public Authority to provide health and dental benefits  
20 to the IHSS Independent Providers, for the period of July 1, 2003 to June 30, 2006, in the  
21 amount of \$56,318,103.
