4 **Resolution authorizing the San Francisco Department of Public Health, Behavioral**
5 **Health Services (SFDPH, BHS) to accept and expend retroactively a grant in the amount**
6 **of \$399,444 from the California Department of Mental Health (CDMH) to develop model**
7 **strategies and protocols for African-Americans institutionalized for mental disease; for**
8 **the period of June 16, 2003, to June 30, 2004.**

10 WHEREAS, SFDPH, BHS has applied for and been awarded a grant from CDMH
11 in the amount of \$399,444 to develop model strategies and protocols for African-Americans
12 institutionalized for mental disease; and,

13 WHEREAS, As a condition of receiving the grant funds, SFDPH, BHS has provided to
14 CDMH a revised workplan and budget; and,

15 WHEREAS, The grant budget includes provision for indirect costs of \$11,784; and,

16 WHEREAS, This Resolution requires expedited review by the Board of Supervisors
17 because we did not receive the grant award notice until April 30, 2003; and,

18 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds
19 may be placed automatically on the consent agendas in committee, as they are usually
20 considered to be routine items, and this resolution authorizes the acceptance and expenditure
21 of grant funding; now, therefore, be it

22 RESOLVED, That SFDPH, BHS is hereby authorized to accept and expend
23 retroactively a grant in the amount of \$399,444 from CDMH; and, be it

24 FURTHER RESOLVED, That SFDPH, BHS is hereby authorized to accept and expend
25 the grant funds in accordance with the requirements set forth in the revised workplan and


1 budget agreement pursuant to San Francisco Administrative Code section 10-170-1; and, be
2 it

3 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
4 agreement on behalf of the City; and, be it

5 FURTHER RESOLVED, That the Controller is directed to designate the positions
6 funded under this agreement as "G" or grant-funded positions which would terminate when
7 the agreement expires.




