15 by reference made a part hereof; and, be it

16 FURTHER RESOLVED, That the Clerk of the Board be hereby directed to transmit a  
17 certified copy of this resolution and its attached report to the Tax Collector who shall cause  
18 the amount of said assessment in each case to be added to the next regular bill for taxes  
19 levied against the property, with a clear notation thereof on said bill.


