

1 [Immediate Release of Ciaran Ferry]

3 **Resolution urging the Bureau of Customs and Immigration to grant asylum to Ciaran**
4 **Ferry.**
5

6 WHEREAS, The United States has historically been a place of refuge for immigrants
7 escaping political turmoil, war, and economic hardships in their country of origin; and,
8

9 WHEREAS, On January 30th, 2003, The Bureau of Customs and Immigration
10 Enforcement (formerly INS) arrested Ciaran Ferry, a thirty one-year old Irish citizen. He was
11 attending a formal interview with his wife in relation to his pending permanent residence
12 application that was filed a year earlier. The official charge against Mr. Ferry was overstaying
13 his visa; and,

14 WHEREAS, Under the Bureau of Customs and Immigration Services own regulations,
15 Ciaran was legally in status when he filled his "green card" application in early 2002; and,

16 WHEREAS, The Department of Homeland has refused to disclose its reason for
17 holding Mr. Ferry and refused to adjudicate his residency application, despite the fact that
18 others in Mr. Ferry's positions are approved for permanent residency on a daily basis; and,

19 WHEREAS, Mr. Ferry's imprisonment is driven by political reasons due to his arrest by
20 British authorities on March 1993, after two weapons were found in a car in which he was a
21 passenger. In which, he was held for two years before being tried without a jury under the
22 Diplock court system, and sentenced to 22 years in Long Kesh, a special prison in the north
23 of Ireland for individuals sentenced for political offenses; and,

24 WHEREAS, Mr. Ferry was sentenced to seven and half years before being released in
25 the summer of 2000 under the Good Friday Accord, brokered by Britain and Ireland with the

1 active involvement of former U.S. President Bill Clinton and former Senator George Mitchell;
2 and,

3 WHEREAS, Mr. Ferry has been held in solitary confinement for 3 months for the
4 relatively minor crime of overstaying his Visa. If Ciaran Ferry is deported to Ireland, his life
5 along with his American spouse and young daughter will be placed in deadly jeopardy; and

6 WHEREAS, The Police Service of Northern Ireland has informed Mr. Ferry that his
7 name is on a paramilitary death list and that his life is in immediate danger; and,

8 WHEREAS, On May 8, 2003, the Irish American Unity Conference, San Francisco
9 Chapter along with other members went on record in support of the immediate release and
10 granting of asylum in the United States to Ciaran Ferry; and,

11 WHEREAS, On July 28, 2003, the San Francisco Labor Council passed a resolution
12 for the immediate release of Ciaran Ferry; now therefore be it,

13 RESOLVED, That the Board of Supervisors joins with the Irish American Unity
14 Conference, San Francisco Chapter and the San Francisco Labor Council to urge the Federal
15 government to terminate imprisonment and deportation proceedings lodged against Mr. Ferry
16 and allow him to return to his family in the United States; and be it,

17 FURTHER RESOLVED, That the Clerk of the Board transmit this resolution to
