3 **Resolution enacting and rescinding parking regulations at various locations.**

4 RESOLVED, That, in accordance with the provisions of the California Vehicle
5 Code and the San Francisco Traffic Code, the following regulations governing the
6 parking of vehicles are hereby enacted or rescinded as designated below:

7 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

8 9th Avenue, east side, from Lake Street to the north terminus (legislates existing
9 street conditions);

10 Diamond Street, west side, from 22nd to 23rd Streets (legislates existing street
11 conditions);

12 Wisconsin Street, both sides, from 19th to 20th Streets (legislates existing street
13 conditions);

14 Wisconsin Street, west side, from 20th to 22nd Streets (legislates existing street
15 conditions);

16 Duboce Avenue, north side, from Castro to Divisadero Streets (legislates existing
17 street conditions);

18 Arkansas Street, west side, from 16th to Mariposa Streets (legislates existing
19 street conditions);

20 Arkansas Street, east side, from Mariposa to 18th Streets (legislates existing
21 street conditions);

22 Arkansas Street, both sides, from 18th to 19th Streets (legislates existing street
23 conditions);

24 Arkansas Street, west side, from 19th to 20th Streets (legislates existing street
25 conditions);

Rhode Island Street, east side, from 20th Street to Mariposa Street (legislates
existing street conditions); and

Rhode Island Street, west side, from 19th Street to Mariposa Street (legislates
existing street conditions).

7 **1-HOUR PARKING METERS, 7 AM TO 6 PM, MONDAY THROUGH SATURDAY -**
8 **ESTABLISH**

9 California Street, north side, from Locust Street to 231 feet easterly (commercial
10 frontage only, up to 3440 California Street).

11 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

12 Farrugut Avenue, north side, from Alemany Boulevard to the western terminus.

13 **RESIDENTIAL PERMIT PARKING AREA "S" (2-HOUR TIME LIMIT, 8 AM - 9 PM,**
14 **MONDAY THROUGH FRIDAY) - ESTABLISH**

15 18th Street, both sides, between Clover and Douglass Streets (4500 block).

16 **NO PARKING ANYTIME - RESCIND**

17 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

18 Langton Street, east side, between Folsom and Harrison Streets.

19 **1-HOUR PARKING, 7 AM TO 6 PM, EXCEPT SUNDAY - RESCIND**

20 **RESIDENTIAL PERMIT PARKING AREA "I" (4 2-HOUR TIME LIMIT, 9 AM - 6 PM,**
21 **MONDAY THROUGH SATURDAY) - ESTABLISH**

22 Julian Avenue, both sides, between 15th and 16th Streets.

23 **RESIDENTIAL PERMIT PARKING AREA "I" (4 2-HOUR TIME LIMIT, 9 AM - 6 PM,**
24 **MONDAY THROUGH SATURDAY) - ESTABLISH**

25 Rondel Place, both sides, between 16th Street and south terminus.

Categorically exempt from Environmental Review Class
1(c)(9) changes in the traffic and parking regulations
where such changes do not establish a higher speed
limit or result in more than a negligible increase in the
use of the street.
