20 County of San Francisco.

21 Conditions: 1) The petitioner(s) shall be responsible for maintaining free of litter  
22 the area adjacent to the premises over which they have control; 2) The petitioner(s)  
23 shall police the area under their control in an effort to prevent the loitering of persons



